- 1. The Audited Annual Accounts for the Financial Year 2019-2020 along with the Audit Report thereon;
- 2. The Audited Financial Results for the Financial Year 2019-2020;
- 3. Recommendation of final dividend on equity shares, if any, for the financial year 2019-2020.
