The financial results are in accordance with the Indian Accounting Standards (Ind AS) as prescribed under Section 133 of the Companies Act, 2013 read with relevant rules in this regard.
- 2 The results for the quarter and nine months ended December 31, 2021 have been subject to a limited review by the statutory auditors of the company. The statutory auditors, Kalyaniwalla & Mistry LLP have issued a limited review report with unmodified conclusion on the standalone and consolidated financial results.
- 3 As the Company's business activity falls within a single operating segment viz "Pharmaceutical and Healthcare", no segment information is disclosed.
- 4 Employee Benefit Expenses includes Share Based Payment expense on account of ESOP Scheme, 2019 of ₹ 452.61 Lakh (Previous Period ₹ 685.60 Lakh) as per Ind AS 102 for the nine months ended December 31, 2021.
- 5 During the nine months ended December 31, 2021, the Company has alloted 5,31,250 equity shares of ₹ 1 each fully paid, on exercise of stock options by employees in accordance with the Company's ESOP scheme, 2019. From the total number of options granted 34,85,000, the outstanding number of options as at December 31, 2021 are 19,67,250.
- In the current quarter, with respect to consolidated financials statements, exceptional items represent impairment of trade receivable pertaining to a wholly owned subsidiary Bliss GVS Clinic Health Care Pte Ltd, Singapore. The said subsidiary has been sold by the Company for a consideration of USD 3,75,000 vide agreement dated 25th Nov, 2021 and is derecognised in the current quarter, though the consideration is received on January 5, 2022 and the concerned shares were transferred on January 12, 2022.
- 7 In the current quarter, standalone financials statements includes exceptional item ₹ 274.51 Lakh on profit on sale of a wholly owned subsidiary namely, Bliss GVS Clinic Health Care Pte Ltd, Singapore.
- 8 The Company has incorporated new step down subsidiary in DRC (100% subsidiary of Bliss International Pte Ltd) on January 15, 2022.
