**Approval of Audited Financial Results:**

Pursuant to Regulation 33 of SEBI(LODR)Regulations, 2015 the Board of Directors of our company had approved the Audited Financial Results for the year ended 31<sup>st</sup> March, 2023. The approved Audited Financial Results along with audit report, Cash Flow Statement for the year ended 31<sup>st</sup> March, 2023 and declaration on the report of auditors with Unmodified opinion are enclosed as Annexure.

The Board of Directors has not recommended any Dividend for the year 2022-23.

The financial results have been prepared in accordance with Indian Accounting Standards (Ind AS) as notified by the Ministry of Corporate Affairs pursuant to Section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standard) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016. The Board also approved revision in remuneration payable to Mr.R. Deenadayalu, Company Secretary and Compliance Officer from Rs.1,51,800/- as basic salary per month with House Rent Allowance of 8% per month to Rs.1,72,000/- as basic salary per month with House Rent Allowance of 8% per month on the basic salary with effect from 1<sup>st</sup> June, 2023.





#### Opinion

We have audited the accompanying standalone quarterly financial results of **M/s CHENNAI MEENAKSHI MULTISPECIALITY HOSPITALS LIMITED** (the company) for the quarter ended March 31, 2023 and the year-to-date results for the period from April 01, 2022 to March 31, 2023 attached herewith, being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us these standalone financial results:

#### Basis for Opinion
