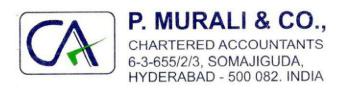

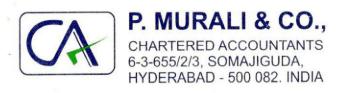

- 3. Loan of Rs. 25.24 crores payable to subsidiary company "Country Vacations International Ltd-Dubai" is recognised as "other income" in the current financial year.
