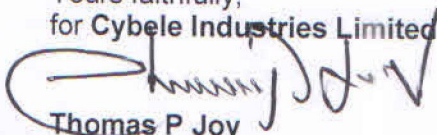

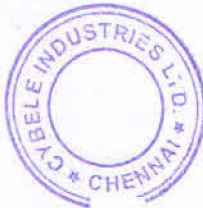

Stalin injects infra boost

Corporates and financial experts have welcomed the maiden budget presented by Chief Minister Stalin yesterday.

Apart from fulfilling the DMK's poll promises many aspects in the budget are pointing at good times ahead for Tamil Nadu. This budget will improve employment outcomes in the state, including women and vulnerable sections of the society, through an enduring, long-term commitment for better opportunities.

Special attention has been given to the growth of its capital, as Chennai's urban area is expected to attain a population of more than one crore by 2025.

Urban growth is the spatial pattern of land development and the process of attaining a form influenced by various factors, and it is driven by population growth, and social and economic development.

Chennai city, the fourth largest metropolitan city of the country, finds 157th rank in the list of

urban areas categorised by developed land area.

The present government headed by Stalin seems to have identified focus areas for Chennai's growth and also for other upcoming cities in this State viz Coimbatore, Madurai etc.

For Chennai, new flyovers and over bridges will be constructed at 3 places in Chennai city at Ganesapuram subway; at the intersection of Konnur High Road – Strahans Road; and at South Usman Road at an estimated cost of Rs.335 crore. Kodambakkam Metro trains is to be taken up at breakneck speed to start services by 2025.

All these are going to be a boon to Chennai's future ambitions. The real estate sector and HR activities in and around Chennai is going to see a new momentum for sure.

Tamil Nadu's current budget on real estate is focused on industrial, warehousing and commercial demands.

The announcement of development of Fintech

park in Nandambakkam, will help ease out prices for private developers as well as corporations and also help developers access clean land parcels. The proposed development area is over 150 acres to house major BSFI companies operating in Chennai. Digital land survey of ponds will now be made available, making this valuable information accessible will be helpful for large land acquisitions. The fixing up of fair compensation price for the landowner will further help speed up and smoothen the acquisition process.

The city of Chennai has received a major infrastructure boost with the announcement of 3 new flyovers. This, added with the development of the second phase of the metro will ease out the traffic and boost the connectivity within the city. For the residential sector, clarity on the direction of property taxes and registration charges will really help bring a positive sentiment to the market."



India & 4 other nations celebrate Independence Day on Aug 15

Validating Moments of Freedom in Shades of Joy

Jawaharlal Nehru, the first Prime Minister of independent India, on the historic night of freedom while leading the country to freedom used these prophetic words, "Long years ago we made a tryst with destiny, and now the time comes when we shall redeem our pledge, not wholly or in full measure but very substantially. At the stroke of the midnight hour, when the world sleeps, India will awake to life and freedom. A moment comes, which comes but rarely in history, when we step out from the old to new..."

Nelson Mandela, architect of dismantling of abhorrent apartheid and freedom fighter of South Africa was very candid about freedom when he said, "For to be free is not merely to cast off one's chains, but to live in a way that respects and enhances the freedom of others."

Since India's 75th Independence Day is round the corner. It made the scribe to search for the dates of independence of other countries. It is a

strange coincidence that five more countries also celebrate their Independence Day on August 15.

The preparations are going on to celebrate the National Day with fervour. The day is historic that marked the end of the colonial rule in the country after a hiatus of nearly 200 years. The dawn of independence ushered the birth of the world's largest democracy.

The unflinching grit and unwavering patriotism of freedom fighters forced the British empire to finally retreat and whose courage and patriotism continue to inspire us to work for a prosperous and stronger India. The best way of celebrating the Independence Day will be to remember with gratitude the legends such as Rani Lakshmi Bai, Bhagat Singh, Mangal Pandey, Chandra Shekhar Azad, Subhas Chandra Bose, Mahatma Gandhi and many more.

Out of five, the remaining four countries commemorating their Independence Day on August 15 are Bahrain, Democratic Republic of

Congo, North & South

Korea and Liechtenstein Bahrain was ruled by the Arabs and Portugal before it became a British protectorate in the 19th century. Finally, the ancient land of the Dilmun (Sumerian name, also Telmun, was an ancient "pre-Arab" East Semitic-speaking civilisation in eastern Arabia mentioned from the 3rd millennium BC onwards) gained independence from its British rulers on August 15, 1971. However, Bahrain decided to celebrate its National Day on December 16 to coincide with the day when its former ruler Isa bin Salman Al Khalifa ascended to the throne.

The Democratic Republic of the Congo, also known as Congo-Kinshasa, DR Congo, the DROC, the DRC, or simply either Congo or the Congo, and formerly Zaire. It is a country in Central Africa, the largest in sub-Saharan Africa, the second-largest in all of Africa, and the 11th-largest in the world. The Republic of Congo came

under French rule in 1880 and became known first as French Congo, then as Middle Congo in 1903. The Central African country gained full independence from French colonial rulers on August 15, 1960.

Korea, or the Korean Peninsula, is a region in East Asia. Since 1945 it has been divided into the two parts which soon became the two sovereign states: North Korea and South Korea are diametrically opposite politically oriented countries. However, North and South Korea celebrate their Independence Days on August 15. Actually, both North Korea and South Korea celebrate August 15 as The National Liberation Day or 'Victory Over Japan'.

Every year, August 15 is celebrated as a holiday in both the countries to commemorate the day when the US and Soviet forces ended the decades-long Japanese occupation of Korea. On this day in 1945, Japan's colonial rule over Korea ended with its Second World War

surrender. However, in 1948, Korea got divided between the Soviet-backed North and the US-backed South. North Korea is known as the Democratic People's Republic of Korea while South Korea is officially named as the Republic of Korea.

Liechtenstein is one of the smallest countries of the world to have got independence from German rule in 1866. The country has been celebrating August 15 as its National Day since 1940. On 5th August 1940, the government of the Principality of Liechtenstein officially declared August 15 to be the country's National Holiday. The epic day is remembered as the birthday of Prince Franz-Josef II who was the reigning Prince of Liechtenstein from 1938 until his death in 1989.

It will be in fitness of things to send a meaningful message for the people of these countries on the Momentous Day, "Carried with care, coated with pride, dipped in love, fly in glory, moments of Freedom in shade of joy."
