Sub: Disclosure of reasons for delay in submission of financial results under Regulation 33 of the SERI (LODR), 2015 for the guarter and of lune 20, 2021

SEBI (LODR), 2015 for the quarter ended June30, 2021.

Ref: SEBI Circular No. CIRICFD/CMD-1/142/2018 dated November 19, 2018

In terms of Regulation 33(3) of the SEBI (LODR) Regulations, 2015, it is our obligation to submit and publish our unaudited financial results for the quarter ended 30<sup>th</sup> June 2021 on or before 15<sup>th</sup> August 2021. However, the Company is not in a position to publish the said results in a timely manner. Therefore, we are not able to comply with the SEBI circular dated 19" November, 2018; we would like to furnish the following reasons for delay in publishing our financial results.

As a result of restrictions imposed by the Government of Tamilnadu on opening of private offices and on travelling due to Covid Pandemic (2nd Wave), the employee/officials are unable to attend the work place. As a result, we are unable to file our fourth quarter and yearly financial results for the year ended 31<sup>st</sup> March 2021 on or before the stipulated date i.e. June 30, 2021. However with great difficulty we have completed our year end statutory audit on 30<sup>th</sup> July 2021 and published our financial results.

After completing our yearend audit of our accounts we have started our quarterly accounts for the quarter ended 30<sup>th</sup> June 2021. We are in the process of completing the unaudited financial results for the quarter ended 30<sup>th</sup> June 2021 on or before 31<sup>st</sup> August 2021.

Therefore we kindly request you to give us fifteen days time to complete our quarterly audit and publish our results.
