We have reviewed the accompanying statement of unaudited financial results of DHRUVA CAPITAL SERVICES LIMITED (CIN- L67120RJ1994PLC008593) for the quarter ended 30TH June, 2023 except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been audited by us.
