- 1 The above unaudited financial results were approved in the meeting of the Board of Directors held on Wednesday, August 05, 2020 after being reviewed and recommended by the Audit Committee.
- 2 The figures for the quarter ended March 2020 are the balancing figures between the audited figures in respect of the full financial year and the published unaudited year to date figures up to the third quarter of the financial year.
- 3 These results have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under Section 133 of the Companies Act, 2013 as amended and other recognized accounting practices and policies to the extent possible.
- 4 The COVID-19 outbreak caused Pan-India disruption of businesses. Sugar being classified as essential product, Government took adequate steps to support industry during lock down period to complete its crushing season without interruption. The company has considered the possible impact of COVID-19 in preparation of financial results for the quarter, including internal & external as known to the company up to the date of approval of these results to assess and finalise the carrying amounts of its assets & Liabilities. The company will continue to closely monitor any material changes in the future economic conditions.
- 5 In view of COVID-19, the Company has started manufacturing hand sanitiser at its distillery unit at Dwarikesh Nagar.
- 6 Given the seasonal nature of the industry, the results of any quarter may not be a true and /or proportionate reflection of the annual

performance of the company. Income tax provision for the quarter is based on the latest estimate of annual profit for the FY 2020-21.

7 Previous period figures have been regrouped and reclassified wherever necessary for the purpose of comparison.

Independent Auditor's Review Report on unaudited quarterly financial results of Dwarikesh Sugar Industries Limited Pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, for the quarter ended June 30, 2020.

To the Board of Directors of Dwarikesh Sugar Industries Limited

- We have reviewed the accompanying statement of unaudited financial result of Dwarikesh Sugar Industries Limited ('the Company') for the quarter ended June 30, 2020 ("the Statement") attached herewith, being prepared by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 (the "Regulations"), as amended to date, which has been initialed by us for identification purpose.
- 2. The preparation of the Statement is in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34, Interim Financial Reporting (Ind AS 34) prescribed under Section 133 of the Companies Act, 2013, as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India, read with the Regulation, is the responsibility of the Company's Management and has been approved by the Board of Directors of the Company. Our responsibility is to express a conclusion on the Statement based on our review.
- 3. We conducted our review of the Statement in accordance with the Standard on Review Engagement (SRE) 2410, "Review of Interim Financial Information performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statements is free of material misstatement. A review is limited primarily to inquiries of the Company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and, accordingly, we do not express an audit opinion.
- 4. Attention is drawn to the fact that the figures for the three months ended 31 March 2020 as reported in the Statement are the balancing figure between audited figures in respect of the full previous financial year and the published year to date figures up to the third quarter of the previous financial year. The figures up to the end of the third quarter of previous financial year had only been reviewed and not subjected to audit.
- 5. Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying Statement prepared in all material respects in accordance with the applicable Indian Accounting Standards (Ind-AS) specified under
