Sub: Intimation on the outcome of the Board Meeting held on November 11, 2022.

We refer to our letters dated October 27, 2022 and November 7, 2022, intimating you about the convening of the meeting of the Board of Directors of the Company to consider the unaudited standalone and consolidated financial results for the quarter and half year ended September 30, 2022 and declaration of Interim Dividend for the financial year 2022-23. In this regard, we wish to inform that the Board of Directors of the Company met today (November 11, 2022) and approved the following:

(a) Unaudited Standalone and Consolidated Financial results for the quarter and half year ended September 30, 2022.

The Board approved the unaudited Standalone and Consolidated Financial results of the Company for the quarter and half year ended September 30, 2022 in the format prescribed under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI (LODR)) and the Limited Review Report of M/s. Price Waterhouse Chartered Accountants LLP, Statutory Auditors on the Standalone and Consolidated financial results for the quarter and half year ended September 30, 2022. The same is enclosed for your records.

A copy of the press release made with regard to the unaudited financial results for the quarter and half-year ended September 30, 2022 is also enclosed.

Pursuant to Regulation 47 of the SEBI LODR, we would be publishing an extract of the consolidated financial results in the prescribed format in English and Tamil newspapers within the stipulated time. The detailed standalone and consolidated financial results of the Company would be available on the website of the Company www.eidparry.com as well on the websites of Stock Exchanges.

(b) Declaration of Interim Dividend

The Board approved the payment of Interim Dividend for the financial year 2022-23 at Rs.5.50/- (Five rupees and fifty paise only) per share, representing 550%, on the equity share of face value of Re.1/- each fully paid. The Record Date for the purpose of payment of Interim Dividend shall be November 23, 2022.

The Interim Dividend shall be paid to those shareholders whose name appear in the Register of Members as on Record Date in respect of shares held in physical form and in case of shares held in dematerialised form, as per the details to be furnished by the Depositories as on the Record Date. The Interim Dividend will be paid on or after December 6, 2022 but within 30 days from date of declaration of Interim Dividend, as provided under the Companies Act, 2013.





(c) Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Installation of a 120KLPD Distillery and 35TPH Incinerator Boiler at Haliyal Unit

The Board of Directors at their meeting held today, have approved the setting up of a 120 KLPD Distillery and 35TPH Incinerator Boiler at the Company's Haliyal unit in Karnataka.

The details which are required to be furnished in terms of Regulation 30 of the Listing Regulations are given below:

The proposed distillery will utilize sugarcane juice / syrup as its principal feedstock during the cane crushing season and also B-Heavy molasses during off season for the manufacture of ethanol, which is expected to have an assured off take by the Oil Marketing Companies under a clear pricing mechanism.

*Includes 120 KLPD Grain/Sugar Syrup/Molasses based distillery at Sankili Unit, Andhra Pradesh, which is in the process of being established, expected to be commissioned by Dec 2022.

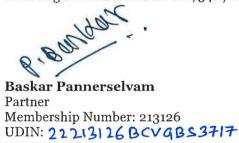

- We have reviewed the standalone unaudited financial results of E.I.D. Parry (India) Limited (the "Company") for the quarter ended September 30, 2022 and the year to date results for the period April 1, 2022 to September 30, 2022, which are included in the accompanying 'Standalone Unaudited Financial Results for the Quarter and Six months ended September 30, 2022', the Standalone Unaudited Statement of Assets and Liabilities as on that date and the Standalone Unaudited Statement of Cash Flows for the six months ended on that date (the "Statement"). The Statement has been prepared by the Company pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations, 2015"), which has been initialled by us for identification purposes.
- 2. This Statement, which is the responsibility of the Company's Management and approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013, and other accounting principles generally accepted in India. Our responsibility is to express a conclusion on the Statement based on our review.
- 3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review of interim financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. - 1 The above Financial Results were reviewed and recommended by the Audit Committee and approved by the Board of Directors at their respective meetings held on November 11, 2022. The Statutory auditors have carried out a limited review of these financial results.
- 2 Exceptional items of Rs. 44.20 Crore for the six months ended September 30, 2022 and quarter ended June 30, 2022 represents properties (including Plant & Machinery) sold relating to Puducherry and Pettavaithalai factories of the Company.

Exceptional item of Rs. 13.73 Crore for the year ended March 31, 2022 represents loss on sale of Plant and Equipment of Puducherry factory which was classified as Asset Held for Sale as at March 31, 2021.

- 3 Pursuant to the exercise of stock options by certain employees, the Company has allotted 46,490 equity shares during the quarter ended September 30, 2022 and 93,930 equity shares during the six months ended September 30, 2022 (quarter and six months ended September 30, 2021: 1,89,973 equity shares) each at the respective exercise price.
- 4 Other Expenses for the six months ended September 30, 2022 and quarter ended June 30, 2022 includes Rs. 10.55 Crores pertaining to Stamp Duty Charges payable pursuant to a Court Order.
- 5 The Board of Directors at its meeting held on November 11, 2022 have approved an interim dividend of Rs. 5.50 per equity share (550% on face value of Re.1 each).
- 6 The Company's significant business is sugar and is identified as an essential service. The possible impact of events arising from COVID 19 pandemic in the preparation of the standalone financial results for the quarter and six months ended September 30, 2022 are not significant.
- 7 Due to the seasonal nature of the business, figures for the current and previous quarters are not comparable.
- 8 Figures for the comparative periods have been regrouped wherever necessary in conformity with present classification.

- 1. We have reviewed the consolidated unaudited financial results of E.I.D. This policy change will result in more appropriate reporting of inventory/cost of goods sold considering the current volatility in input costs and also ensures consistency of policy adopted for other items of inventory and with general industry practice. The impact of this policy change on previous periods is not material.
- 4 Exceptional items of Rs. 44.20 Crore for the six months ended September 30, 2022 and quarter ended June 30, 2022 represents properties (including Plant & Machinery) sold relating to Puducherry and Pettavaithalai factories of the Holding Company.

Exceptional item of Rs. 13.73 Crore for the year ended March 31, 2022 represents loss on sale of Plant and Equipment of Puducherry factory of the Holding Company which was classified as Asset Held for Sale as at March 31, 2021.

5 Other Expenses for the six months ended September 30, 2022 and quarter ended June 30, 2022 includes Rs. 10.55 Crores recognised by the Holding Company pertaining to Stamp Duty Charges payable pursuant to a Court Order.

Other Expenses for the quarter and six months ended September 30, 2022 includes Rs. 60.14 Crores incurred by Parry Sugars Refinery India (Private) Limited (PSRIPL), a subsidiary of the Company on account of delay in clearance of shipments consequent to accidents at PSRIPL's factory.

6 (a) Pursuant to the Share Sale Agreement (SSA) dated May 06, 2022, Coromandel International Limited (CIL), a subsidiary of the Company, through its wholly owned subsidiary, Coromandel Chemicals Limited has acquired 45% of the issued capital of Baobab Mining and Chemicals Corporation S.A. (BMCC) for an upfront consideration of Rs. 156.60 Crores. Consequent to this acquisition, BMCC has become an associate of CIL with effect from September 05, 2022 upon satisfactory completion of the closing conditions under the SSA and has been consolidated with effect from that date. The transaction was accounted in accordance with Ind AS 28 - Investments in Associates and Joint Ventures.

(b) CIL, through its wholly owned subsidiary, Dare Ventures Limited has invested Rs. 10 Crores in EcoZen Solutions Private Limited and Rs. 16.5 Crores in String Bio Private Limited.

- 7 On April 26, 2022, the Hon'ble National Company Law Tribunal, Hyderabad (NCLT) has approved a Scheme of Amalgamation ('Scheme') of Coromandel SQM (India) Private Limited (CSQM) and Liberty Pesticides and Fertilizers Limited (LPFL) (wholly owned subsidiaries of Coromandel International Limited (CIL)) with CIL with effect from April 01, 2021, being the appointed date under the said Scheme.
- 8 The Group's significant business is in Agriculture and allied products (Fertiliser, Sugar etc) and it has been identified as an essential service. The possible impact of events arising from COVID 19 pandemic in the preparation of the consolidated financial results for the quarter and six months ended September 30, 2022 are not significant.

Chennai, November 11, 2022: EID Parry (India) Limited, one of the largest manufacturers of Sugar in India, has reported financial results for the quarter and half year ended 30th September 2022.

Standalone performance for the quarter and half year ended 30th September 2022:

The Standalone revenue from operations for the quarter ended 30th September 2022 was Rs. 646 Crore registering a growth of 47% as against Rs. 438 Crore in the corresponding quarter of previous year. Earnings before depreciation, interest and taxes (EBITDA) for the quarter ended was Rs. 125 Crore as against Rs. 115 Crore in the corresponding quarter of previous year. Standalone profit after tax for the quarter was Rs. 85 Crore as against Rs. 73 Crore in the corresponding quarter of previous year.

The Standalone revenue from operations for the half year ended 30th September 2022 was Rs. 1,368 Crore registering a growth of 54% as against Rs. 888 Crore in the corresponding period of previous year. Earnings before depreciation, interest and taxes (EBITDA) and before exceptional items for the half year ended was Rs. 136 Crore against Rs. 111 Crore in the corresponding period of the previous year. Standalone profit after tax for the half year ended was Rs. 98 Crore against Rs. 40 Crore in the corresponding period of previous year. The profit after tax for the half year ended includes an exceptional gain of Rs. 44 Crore on account of sale of properties relating to Puducherry and Pettavaithalai factories as against Rs. Nil in the corresponding period of previous year.

Consolidated performance for the quarter and half year ended 30th September 2022:

The consolidated revenue from operations for the quarter ended 30th September 2022 was Rs. 11,328 Crore registering an increase of 62% as against Rs. 6,978 Crore in the corresponding quarter of previous year. Earnings before depreciation, interest and taxes (EBITDA) for the quarter ended 30th September 2022 was Rs. 978 Crore registering an increase of 27% as against Rs. 772 Crore in the corresponding quarter of previous year. Consolidated profit after tax and non-controlling interest was Rs. 241 Crore compared to Rs. 244 Crore in corresponding quarter of previous year.







The consolidated revenue from operations for the half year ended 30th September 2022 was Rs. 18,474 Crore registering an increase of 63% as against Rs. 11,333 Crore in the corresponding period of previous year. Earnings before depreciation, interest and taxes (EBITDA) and before exceptional items for the half year ended 30th September 2022 was Rs. 1,732 Crore as against Rs. 1,266 Crore in the corresponding period of previous year. The Consolidated Farm Input operations reported a Profit before Interest and Tax of Rs. 1,061 Crore for the quarter (corresponding quarter of previous year: Profit of Rs. 732 Crore).

Nutraceuticals Division

For the quarter, Consolidated Nutraceuticals division registered a Loss before Interest and Tax of Rs. 3 Crore (corresponding quarter of previous year: Loss of Rs. 8 Crore).

Dividend

The Board of Directors at its meeting held on November 11, 2022, have approved an interim dividend of Rs. 5.50 per equity share (550% on face value of Re. 1 each).

Mr. S Suresh, Managing Director commenting on the results mentioned that

"Sugar and Distillery segments have performed better in Q2 2022-23 as compared to the corresponding quarter of the previous year on account of increased sales volumes and realisations and better sales mix in Distillery, while the Cogen profitability has been impacted due to increase in coal prices.

Cane crushing volumes have increased to 8.4 LMT in Q2 2022-23 as against 6.6 LMT in Q2 2021-22. The Company operated Special Season in Tamil Nadu till October 2022.







The Government has brought in Release Order for Exports and the quota allocated to the Company was 0.31 LMT to be fulfilled before October 31, 2022. The Company has exported already exported 0.28 LMT in Q2 22-23.

Base FRP for sugar season 2022-23 has been increased to Rs. 3,050/MT for a base recovery of 10.25%.

During the quarter, the Board has approved the setting up of a 120 KLPD Distillery in Haliyal with a capital outlay of Rs. 181 Crores.

Standalone Nutraceuticals business had a profit in registered a strong increase in profit to Rs. 5 Crore in Q2 2022-23 as against Rs. 2 Crore in corresponding quarter of the previous year on account of increased sales realisations and reduction in input costs. The Consolidated Nutra segment Loss has reduced to Rs. 3 Crore in the current quarter as against Rs. 8 Crores in the previous period."
