Report on the Standalone Financial Statement

Opinion

We have audited the accompanying Statement of Standalone Financial Results of **ELCID INVESTMENTS LIMITED** (the "Company"), for the quarter and year ended March 31, 2023 (the "Statement"), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
