Review Report to, The Board of Directors, Ludlow Jute & Specialities Limited KCI Plaza, 23C, Ashutosh Chowdhury Avenue, 4th Floor, Kolkata – 700 019,

- We have reviewed the accompanying unaudited financial results of M/s. Ludlow Jute & Specialities Limited ('the Company') for the quarter ended June 30, 2019 together with notes thereon (herein after referred to as 'the Statement'), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the Regulation) as amended, read with SEBI Circular No. CIR/CFD/CMD1/44/2019 dated March 29, 2019 ('the Circular').
- 2. This Statement, which is the responsibility of the Company's Management and approved by the Board of Directors in their meeting held on August 6, 2019, has been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under section 133, of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to issue a report on the Statement based on our review.
- 3. We conducted our review of the statement in accordance with the Standard on Review Engagement (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity," issued by The Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the statement is free of material misstatement. A review is limited primarily to inquiries of Company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
- 4. Based on our review conducted as stated above, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the applicable Indian Accounting Standards as prescribed under Section 133 of the Companies Act, 2013, as amended read with relevant rules issued there under and other recognized accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of the Regulation, read with the Circular, including the manner in which it is to be disclosed, or that it contains any material misstatement.

Notes:

1 The Financial Results of the Company for the quarter ended 30th June,2019 have been reviewed by the Audit Committee and approved by the Board of directors of the Company at their respective meeting held on 8th August, 2019, and Limited Review of the same has been carried out by the Statutory Auditors.

2 As the Company's business activity falls within a single significant primary business segment i.e. Jute Goods, no separate segment information is disclosed.

3 The Company has adopted Ind AS 116 'Leases' using the modified retrospective approach with the date of initial application being April 1, 2019, for building lease previously classified as Operating Lease, the application of IND AS 116 has resulted in recognition of Right to use asset and equivalent lease liability amounting to Rs.88.66 lakhs at at April I, 2019. In the statement of profit & loss for the current period, operating lease expense being "Rent" has been changed to Depreciation on Right to use assets and Interest on lease liability. During the quarter, the Company has recognized depreciation & interest expense amounting Rs.7.39 lakhs and Rs. 1.73 lakhs respectively which has resulted in decrease in profit before tax amounting to Rs.0.35 lakhs."

4 The Hon'ble Supreme Court of India ("SC") by their order dated February 28, 2019, in the case of Surya Roshni Limited v/s EPFO, set out the principles based on which allowances paid to the employees should be identified for inclusion in basic wages for the purposes of computation of Provident Fund contribution. Subsequently, a review petition against this decision has been filed and is pending before the SC for disposal. The Company is awaiting the outcome of the review petition, and also directions from EPFO, if any. Until further directions in the matter from the aforementioned authorities, the Company has calculated and made provision of the required amount prospectively, being the employers & employees contribution towards Provident Fund upto 30th June, 2019.

5 The figures for the quarter ended 31st March 2019 are the balancing figures between audited figures in respect of the full financial year ended 31st March 2019 and the year to date figures up to the third quarter ended 31st December 2018 SPECIA
